Please consider a position on the board, current officers will be available to assist in the transition.

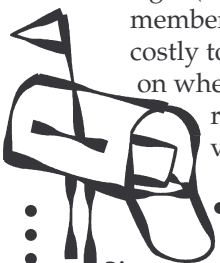
At the Spring meeting a motion will be put on the table to permanently move Board Member Elections to the Spring, when meeting attendance is higher.
